

# USA Compression Partners Announces Fifth Consecutive Quarterly Distribution Increase since IPO; Second Quarter 2014 Earnings Release and Conference Call Scheduled for August 12

AUSTIN, Texas--(BUSINESS WIRE)--Jul. 24, 2014-- USA Compression Partners, LP (NYSE: USAC) (the "Partnership") today announced an increased cash distribution of \$0.50 per unit on its common and subordinated units for the second quarter of 2014, which corresponds to an annualized distribution rate of \$2.00 per unit, up from the first quarter's distribution rate of \$0.49 per unit, or an annualized rate of \$1.96. The Partnership's second quarter distribution rate is an increase of 2.0% over the first quarter of 2014 and is up 13.6% year-over-year. The distribution will be paid on August 14, 2014, to unitholders of record as of the close of business on August 4, 2014.

USA Compression Holdings, LLC, the owner of 41.3% of the Partnership's outstanding limited partnership units, and Argonaut Private Equity and certain related parties, the owners of 16.0% of the Partnership's outstanding limited partnership units, have committed to reinvest all of this distribution with respect to their units pursuant to the Partnership's Distribution Reinvestment Plan.
