



USA Compression Partners Announces First Quarter 2016 Distribution; First Quarter 2016 Earnings Release and Conference Call Scheduled for May 5

AUSTIN, Texas--(BUSINESS WIRE)--Apr. 21, 2016-- USA Compression Partners, LP (NYSE: USAC) (the "Partnership") today announced a cash distribution of \$0.525 per common unit for the first quarter of 2016, which corresponds to an annualized distribution rate of \$2.10 per unit, flat from the fourth quarter's distribution rate. The distribution will be paid on May 13, 2016, to unitholders of record as of the close of business on May 3, 2016.

In addition, the Partnership announced today it will release its first quarter 2016 results prior to the opening of U.S. financial markets on Thursday, May 5.
