

# USA Compression Partners, LP Announces Third Quarter 2019 Distribution; Third Quarter 2019 Earnings Release and Conference Call Scheduled for November 5

AUSTIN, Texas --(BUSINESS WIRE)--Oct. 17, 2019-- USA Compression Partners, LP (NYSE: USAC) (the "Partnership") today announced a cash distribution of \$0.525 per common unit for the third quarter of 2019, which corresponds to an annualized distribution rate of \$2.10 per unit, unchanged from the second quarter's distribution rate. The distribution will be paid on November 8, 2019, to unitholders of record as of the close of business on October 28, 2019.

In addition, the Partnership announced today it will release its third quarter 2019 results prior to the opening of U.S. financial markets on Tuesday, November 5.
